IT IS HEREBY ENACTED by the Legislature of the State of Trengganu as follows:

1. This Enactment may be cited as the Public Officers Short title (Conduct and Discipline) (General Orders, Chapter D) and com-Regulations, 1969 (Application to the State of Trengganu) mencement. Enactment, 1971 and shall be deemed to have come into force on the 15th day of October, 1969.

2. The Public Officers (Conduct and Discipline) (General Adoption of Orders, Chapter D) Regulations, 1969 as set out in the Schedule to the Essential (General Orders, Chapter D) Regulations, 1969 is hereby adopted subject to the modifications set out in the Schedule hereto and shall apply and have effect in relation to members of the public service of the State of Trengganu.

3. The Emergency (Trengganu) Enactment No. 1, 1969 is hereby repealed.

## SCHEDULE (Modifications)

- 1. For "of Clause (5A), (5B) or (6A) of Article 144 of the Constitution" appearing in the definition of "Disciplinary Authority" in General Order 2 substitute "of Clause (9A) of Article LVI of Part I of the State Constitution".
- 2. In General Order 3 (a) insert the word "Ruler," after the words "the Yang di-Pertuan Agong" thereof.

- 3. Unless the context otherwise requires—
  - (a) for "Government" wherever it appears therein substitute "State Government";
  - (b) for "Director-General of Public Service" wherever it appears therein substitute "State Secretary";
  - (c) for "Attorney-General" wherever it appears therein substitute "State Legal Adviser";
- 4. For paragraph (iii), (iv), (v) and (vi) of General Order 37 substitute the following—
  - "(iii) all fines and forfeitures shall be deducted from the monthly emoluments of the officer concerned and shall be paid or transferred to the State Financial Officer for credit to a fund known as the Fines Fund;
  - (iv) an annual return shall be made by the State Financial Officer showing the balance at credit of the Fines Fund on 31st December each year and the amounts paid by respective departments during the preceding twelve months;
  - (v) the Menteri Besar may direct the manner in which the Fund shall be disbursed subject to the provision that disbursements shall be made either in a manner beneficial to officers serving within the department within which the fines were imposed or in a manner beneficial to officers in general".
