An Enactment to make provision for the remuneration of the Regent or Council of Regency authorised by law to exercise the functions of the Sultan of Trengganu.

[1st January, 1965]

IT IS HEREBY ENACTED by the Legislature of the State of Trengganu as follows:

1. This Enactment may be cited as the Regent or Council Short title of Regency (Remuneration) Enactment, 1965, and shall and commencement. come into force on the 1st day of January, 1965.

2. (1) There shall be paid to the Regent or Council of Payment to Regency authorised by law to exercise the functions of the Regent or Council of Sultan during any period during which he exercises the Regency functions of the Sultan such sum as may be fixed by law to resolution of the Legislative Assembly in addition to any sum that the person or persons so appointed may otherwise the functions of the Sultan. receive:

Provided that the total sum payable shall not exceed the allowance which would be payable to the Sultan under the State Constitution or any other written laws.

- (2) The sum payable under sub-section (1) shall—
 - (a) accrue from day to day; and
 - (b) be payable on the last day of each month or on such other day as the State Financial Officer may from time to time determine.
- 3. (1) There shall be paid to the Comptroller of the Entertain-Household in respect of any period during which the ment. Regent or Council of Regency exercises the functions of the Sultan the monthly sum of five hundred and fifty dollars (\$550/-) for entertainment:

Provided that the person or persons so appointed shall not be entitled to receive any entertainment allowance payable to him or to them prior to his or to their being so appointed in respect of the period during which the Regent or Council of Regency exercises the functions of the Sultan.

- (2) The sum payable under sub-section (1) shall accrue and be payable in the same manner as the sum payable under sub-section (2) of section 2.
- 4. There shall be paid to the Comptroller of the Household in respect of any period during which the Regent or Council of Regency exercises the functions of the Sultan the monthly sum of two hundred and eight dollars and cents thirty-three (\$208.33) as Royal Bounty.
- 5. The sums required for the payments under sections 2, 3 and 4 shall be charged on the Consolidated Fund of the State.
