THE TRENGGANU NATIONALITY REGULATIONS, 1952.

In exercise of the powers conferred upon him by section 17 of the Trengganu Nationality Enactment, 1952, the Ruler in Council bereby makes the following regulations:

1. These regulations may be cited Nationality Regulations, 1952. as the Trengganu Title.

2. In these regulations, unless the context otherwise Interpretation.
