THE TRENGGANU NATIONALITY ENACTMENT, 1952.
(Trengganu Enactment No. 3 of 1952.)

THE TRENGGANU NATIONALITY REGULATIONS, 1952.

In exercise of the powers conferred upon him by section 17 of the Trengganu Nationality Enactment, 1952, the Ruler in Council hereby makes the following regulations:

1. These regulations may be cited as the **Trengganu Nationality Regulations, 1952.** Title.

2. In these regulations, unless the context otherwise requires— Interpretation.

“the Enactment” means the Trengganu Nationality Enactment, 1952;

“the register” means the Register of Trengganu Nationals kept in accordance with the provisions of Regulation 9 of these regulations;

“the Registrar” means the Registrar of Trengganu Nationals appointed by the Ruler under Regulation 3 of these regulations, and includes a Deputy Registrar.

3. The Ruler may, by notification in the *Gazette*, appoint a Registrar of Trengganu Nationals and as many Deputy Registrars as he deems necessary in order to give effect to the objects of the Enactment. Appointments

(1) Any person who claims to be a subject of the Ruler under section 4 of the Enactment may make application to the Registrar in the Form A1 set out in the Schedule hereto for a certificate that he has produced *prima facie* proof that he is a subject of the Ruler by operation of law. (2) Upon receipt of any such application and upon production to him of such evidence as appears to him to be satisfactory the Registrar shall grant to the applicant a certificate (hereinafter called a certificate of *prima facie* status) in the Form A2 set out in the Schedule hereto.

5. (1) An application for registration as a subject of the Ruler under sub-section (1) of section 5 of the Enactment shall be made in the Form B1 set out in the Schedule hereto.

(2) A certificate of registration as a subject of the Ruler shall be in the Form B2 set out in the Schedule hereto.

(3) An application for certification by the Ruler under the proviso to sub-section (1) of section 5 of the Enactment that a person who has absented himself from the Federation for a continuous period of five years during the ten years immediately preceding the date of his application for registration has during the period of his absence maintained a substantial connection with the Federation shall be in the Form C set out in the Schedule hereto.

(4) If an applicant for a certificate under paragraph (3) of this regulation is certified by the Ruler to have maintained substantial connection with the Federation during his absence therefrom and the Registrar is satisfied that the applicant is otherwise qualified to be registered the Registrar shall grant to the applicant a certificate of registration in the Form B2 in the Schedule hereto.

6. (1) An application by a woman for registration as a subject of the Ruler under sub-section (3) of section 5 of the Enactment shall be made in the Form D set out in the Schedule hereto.

(2) Upon receipt by the Registrar of any such applications and upon production to him of such evidence as appears to him to be satisfactory, and upon the taking by the applicant of the prescribed oath, the Registrar shall grant to the applicant a certificate of registration in the Form B2 set out in the Schedule hereto.

7. (1) An application for the registration of a minor child as a subject of the Ruler under section 6 of the Enactment shall be made in the Form E set out in the Schedule hereto.

(2) Upon receipt of any such application and upon production to him of such evidence as appears to him to be satisfactory the Registrar shall grant to the applicant a certificate of registration in the Form B2 set out in the Schedule hereto.

8. (1) An application for a certificate of naturalisation under sub-section (1) of section 8 of the Enactment shall be made in the Form F1 set out in the Schedule hereto.

(2) The Registrar shall sign every entry in the register.

(3) The particulars to be recorded in respect of a woman to whom a certificate of registration has been issued under paragraph (2) of Regulation 6 of these regulations shall include the name of her husband or former husband by reason of whose status as a subject of the Ruler she was granted a certificate of registration and the name of her husband or former husband shall be entered after her National Registration Identity Card Number and shall be preceded by the words "wife of" or "formerly wife of" as the case may be.

10. (1) Any person who, being a subject of the Ruler, expects to be absent from the Federation for a continuous period of five years or more may at any time before the expiration of the said period make application to the Ruler under sub-section (2) of section 9 of the Enactment in the Form H1 set out in the Schedule hereto for a certificate that he is maintaining substantial connection with the Federation. The certificate, if granted, shall be in the Form H2 set out in the Schedule hereto.

Application for a certificate of connection with the Federation.

(2) If the applicant is certified by the Ruler to be maintaining substantial connection with the Federation the Registrar shall, unless particulars of the applicant are already recorded in the register, record therein the particulars for which provision is made in Form G, and shall include therein a reference to the certificate of the Ruler.

(3) Any person who has ceased to be a subject of the Ruler by virtue of the provisions of sub-section (1) of section 9 of the Enactment and who resumes residence within the Federation may make application under sub-section (4) of the said section in the Form J set out in the Schedule hereto for reinstatement as a subject of the Ruler.

(4) Upon receipt of any application under paragraph (3) of this regulation the Ruler may, in his absolute discretion, direct

(a) in the case of a person previously registered under Regulation 9 of these regulations

(i) that any former certificate granted to him under these regulations be delivered up to the Registrar and revoked; and

(ii) that a fresh certificate of *prima facie* status, certificate of registration or certificate of naturalisation, as the case may be, be granted to him;

(b) in the case of a person not previously registered under Regulation 9 of these regulations, that a certificate of *prima facie* status, be granted to him and that he be registered accordingly.

11. The Registrar shall file in his office a copy (hereinafter called the office copy) of any certificate granted to any person under the provisions of these regulations, together with the original of the application therefor.

12. (1) A declaration of renunciation of the status of a subject of the Ruler under section 10 of the Enactment shall be made in the Form K set out in the Schedule hereto.

(2) If the declaration of renunciation of status is made within the Federation it may be made before any Magistrate, Justice of the Peace, Notary Public, Advocate and Solicitor or Commissioner for Oaths within the Federation. If the declaration is made outside the Federation it shall be attested as follows:

(a) if made in the Colony of Singapore, by a Magistrate, Justice of the Peace, Notary Public, Advocate and Solicitor or Commissioner for Oaths in the Colony;

(b) if made in the United Kingdom or in any Commonwealth country, British colony, protectorate, protected State, mandated territory or trust territory, by a Notary Public or Commissioner of the Supreme Court of Judicature empowered to take affidavits in that Court;

(c) if made in any other place, by a British Consular Officer or by any person of a class approved in that behalf by the Ruler.

(3) The fee payable for the registration of a declaration of renunciation of status shall be five dollars and shall be payable to the Registrar by the person making the declaration, provided that the Menteri Besar may in his discretion in any particular case waive the payment of the fee.

13. (1) Where any person registered under Regulation 9 of these regulations—

(a) ceases to be a subject of the Ruler under the provisions of section 9 of the Enactment;

(b) renounces the status of a subject of the Ruler under the provisions of section 10 of the Enactment in the manner prescribed in Regulation 13 of these regulations; or

(c) is deprived of the status of a subject of the Ruler under the provisions of section 11 of the Enactment,
