## AKTA JALAN, PAKSI DAN BANGUNAN 1974

Undang-Undang Kecil (Majlis-Majlis Kerajaan) Jalan, Paksi dan Bangunan  
(Terengganu) (Pindaan) 2005

Pinda menjadikan kuasa yang diberikan oleh Seksyen 111, Akta Jalan, Paksi dan Bangunan 1974 [Akta 117], Pihak Berkuasa Negeri tersebut undang-undang kecil berikut.

### Nama dan perincian undang-undang

1. (1) Undang-undang kecil ini berjudul "Undang-Undang Kecil (Majlis-Majlis Kerajaan) Jalan, Paksi dan Bangunan (Terengganu) (Pindaan) 2005".

(2) Undang-undang kecil ini mula berkuat kuasa pada 1 Disember 2005.

### Pindaan Undang-Undang Kecil 1

2. Undang-Undang Kecil (Majlis-Majlis Kerajaan) Jalan, Paksi dan Bangunan (Terengganu) 1974 (No. P.11: 147194) yang disebut "Undang-Undang Kecil 94" dalam undang-undang kecil ini, dipinda dalam undang-undang kecil dengan memasukkan sebagai perincian "79", perincian "79a,".

### Prosedur Undang-Undang Kecil 3

3. Perenggan 3(1) Undang-Undang Kecil Berjaya dengan menggunakan dengan perenggan berikut:

"3. (1) Jumlah wang yang dibekudahi dipergai bagi mengkompaan suatu kaulahan tidak boleh lebih daripada lima puluh peratus daripada jumlah maksimum yang dipergai kaulahan itu boleh dibekukan oleh Akta atau undang-undang kecil yang dibuat di bawahnya dan selangnya jumlah lima puluh peratus daripada denda maksimum yang dipergai kaulahan itu boleh dibekukan barang daripada lima atau lapan, wang yang dibekudahi dipergai bagi mengkompaan kaulahan tersebut hendaklah tidak lebih daripada lima atau lapan".

### STREET, DRAINAGE AND BUILDING ACT 1994

Street, Drainage and Building (Compounding of Offences) (Terengganu) (Amendment) By-Laws 2003

In exercise of the powers conferred by Section 113 of the Street, Drainage and Building Act 1994 [Act 417], the State Authority makes the following by-laws:

#### Citation and commencement

1. (1) These by-laws may be cited as the **Uniform Building By-Laws (Terengganu) (Amendment) 2003**.

(2) These by-laws shall come into operation on 1 December 2003.

#### Amendment of By-Laws 2

2. The Street, Drainage and Building (Compounding of Offences) (Terengganu) By-Laws 1994 [S. P.O. 16/1994], which in these by-laws are referred to as the "principal By-Laws", is amended in by-laws by inserting after the word "By-Laws" the word "2003".

### Amendment of By-Laws 3

3. Paragraph 1 (1) of the principal By-Laws is amended by substituting the following paragraph:

"1. (1) The sum of money to be collected for compounding an offence shall not exceed fifty per centum of the maximum fine with which such offence is punishable under the Act or by-laws made thereunder and if the amount of fifty per centum of the maximum fine with which such offence is punishable less than five hundred rupees, the sum of money to be collected for compounding such offence shall not exceed five hundred rupees".
