LAWS OF THE CONSTITUTION OF TERENGGANU
(FIRST PART)

TERENGGANU STATE PUBLIC SERVICE DISCIPLINARY BOARD
(AMENDMENT) REGULATIONS 1989

IN exercise of the powers conferred by Clause (9A) of Article LVI of the Laws of the Constitution of Terengganu (First Part), the Ruler in Council hereby makes the following Regulations:
