TRENGGANU STATE PUBLIC SERVICE PROMOTION BOARD (AMENDMENT)
REGULATIONS, 1973

IN exercise of the powers conferred by Clause (9A) of Article LVI of
the Laws of the Constitution of Trengganu (First Part) the Ruler in
Council hereby makes the following Regulations:

1. These Regulations may be cited as the **Trengganu State Public
Service Promotion Board (Amendment) Regulations, 1973** and shall be
deemed to have come into force on the 1st day of December, 1973.

2. The Schedule to the Trengganu State Public Service Promotion
Board Regulations, 1968 is hereby amended as follows—

(i) Paragraph 1 ... substitute the words "the Managerial and
Professional Group and the Executive
and Sub-Professional Group" for the words
"Division I and II" wherever they appear;

(ii) Paragraph 2 ... substitute the words "THE CLERICAL AND
THE TECHNICAL GROUP AND THE SUBOR-
DINATE AND MANUAL GROUP" for the words
"DIVISIONS II AND IV AND THE INDUSTRIAL
AND MANUAL GROUP";

(iii) Paragraph 2 ... substitute the words "Assistant State Secre-
tary (Service Branch)" for the words "Pre-
sident, Town Council, Kuala Trengganu".

- (i) Barisan pertama ... gantikan dengan perkataan-perkataan "KUMPULAN PENGURUSAN DAN IKTISAS DAN KUMPULAN KERJA DAN SEPARA IKTISAS" bagi perkataan-perkataan "BAHAGIAN I DAN II";
- (ii) Barisan kelima ... gantikan dengan perkataan-perkataan "KUMPULAN PERKERANIAN DAN TEKNIK DAN KUMPULAN KAKITANGAN RENDAH DAN BURUH KASAR" bagi perkataan-perkataan "BAHAGIAN III, IV DAN KUMPULAN BURUH-BURUH PERUSAHAAN DAN BURUH-BURUH KASAR";
- (iii) Dalam syarat di perenggan penghabisan ... gantikan dengan perkataan-perkataan "Pegawai dalam Kumpulan Pengurusan dan Iktisas atau Kumpulan Kerja dan Separata Iktisas" bagi perkataan-perkataan "Pegawai Bahagian Satu dan Dua".

(FIRST PART)

TRENGGANU STATE PUBLIC SERVICE DISCIPLINARY BOARD
(AMENDMENT) REGULATIONS, 1973

IN exercise of the powers conferred by Clause (9A) of Article LVI of the Laws of the Constitution of Trengganu (First Part) the Ruler in Council hereby makes the following Regulations:

1. These Regulations may be cited as the **Trengganu State Public Service Disciplinary Board (Amendment) Regulations, 1973** and shall be deemed to have come into force on the 1st day of December, 1973. Citation and commencement.
2. The Schedule to the Trengganu State Public Service Disciplinary Board Regulations, 1968 is hereby amended as follows— Amendment of Schedule. Tr. P.U. 12/1968.
 - (i) First line ... substitute the words "THE MANAGERIAL AND PROFESSIONAL GROUP AND THE EXECUTIVE AND SUB-PROFESSIONAL GROUP" for the words "DIVISION I AND II";

- (ii) Fifth line ... substitute the words "THE CLERICAL AND THE TECHNICAL GROUP AND THE SUBORDINATE AND MANUAL GROUP" for the words "DIVISIONS III, IV AND IN THE INDUSTRIAL MANUAL GROUP";
- (iii) In proviso to last paragraph ... substitute the words "the Managerial and Professional Group and the Executive and Sub-Professional Group" for the words "Division I or Division II".
